Over the years we have changed our focus, from initially dealing mainly with lower value road traffic and work accident claims, to the present day where the majority of our work is of higher value and usually relates to more local clients. To reflect this shift, we changed our name to **Stonehewer Moss Solicitors** in 2016.

Since starting, Stonehewer Moss have trained many personal injury lawyers, some who still work for the firm and some of whom have spread their wings, working all over the country.

We now maintain our focus on helping accident victims, including some of the most seriously injured.
