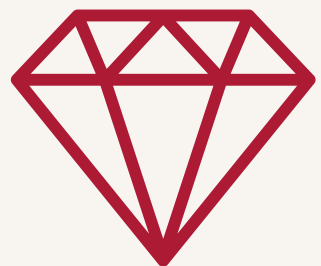


How we can help you.

Free no obligation referral to you of other legal enquiries that we receive from our own clients.

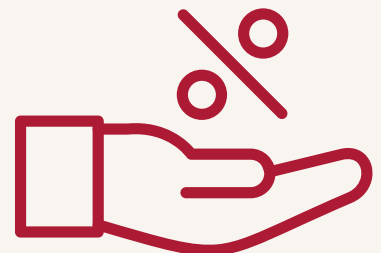


Our PI.Link Scheme

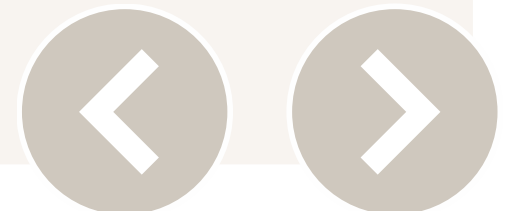
We pay your £200 plus VAT for every PI and Clinical Negligence referral you make to use as soon as we enter into a retainer with the client.
